Dear Mr. Singh:

This is in response to your request dated 01 September 2009 for information regarding **MR. BENBER DAYAO YU**. In so far as PATAFA is concerned, Mr. Yu was recommended to the Philippine Sports Commission (PSC) as Assistant Coach effective 21 January 2008 (see request of PATAFA dated 14 January 2008).

While waiting for the approval from the PSC and the supposed renovation of the track oval, PATAFA made a request for the transfer of the training team to ULTRA Pasig City for the continuance of the training for which Mr. Yu is one of the coaches in the list to be transferred.

Consequently, the PSC responded that they are giving PATAFA a go signal to transfer to ULTRA, **but Mr. Yu was excluded** because that time, the roster of our coaches and athletes has not yet acted upon by the PSC Board of Commissioners (see attached letter dated 15 March 2008).

We hope that this will satisfy your query.

This refers to your query if the Philippine Amateur Track and Field Association (PATAFA) coaches and athletes could transfer to PSC-PhilSports Complex (ULTRA) during the two-month repair of the Rizal Track - Football Stadium.

Please be advised that the Commission has given the go signal for PAFATA coaches and athletes under our official roster to transfer to PSC-PhilSports Complex.

However, upon verification of the list PATAFA submitted to us, Mr. Benber Yu--Assistant Coach--is yet to be part of the official list of the National Athletics Coaching Staff. His application to be a member of your coaching team is still under evaluation. **Hence, Mr. Yu is excluded from the approval.**

At present, the Commission's foremost objective is to allow only the national athletes and coaches to be billeted under PSC-controlled dormitories.
